The residence and curtilage located at 5108 Birchleaf Drive Raleigh, North Carolina 27606-9360. The residence is a two story brick home. The residence is red brick in color with black shutters. The residence has a small wooden-railed front porch that extends left of the front door.

The structure to be searched is located by the following directions: From downtown Raleigh, NC proceed south on Lake Wheeler Road from the intersection of Lake Wheeler and South Street. Proceed south on Lake Wheeler Road to the intersection of Yates Mill Pond Road and turn right. Proceed a very short distance on Yates Mill Pond and turn left on to Penny Road. Proceed southwest on Penny Road to the second street on the left, and turn left on Birchleaf Drive. Proceed south on Birchleaf to 5108 Birchleaf Drive Raleigh, North Carolina.

Continuation of: Probable Cause;

This affiant is an Investigator for the Wake County Sheriff's Office. The affiant has been employed with the Wake County Sheriff's Office as a Law Enforcement Officer for 25 years and is currently assigned to the Criminal Investigations Division as a Deputy Sheriff Investigator Sergeant. During the course of employment as a Law Enforcement Officer, this affiant has received training in drug investigations, juvenile investigations, general investigations and covert law enforcement operations. This affiant has used this training in investigations where there were arrests and convictions of individuals involved in felony and misdemeanor violations of law. This affiant makes this affidavit based on my personal knowledge together with information received from other persons this affiant believes to be credible.

On 11-03-06 the Wake County Sheriff's Office received information that a deceased body had been found by a family member at 5108 Birchleaf Drive Raleigh, North Carolina in the Echanted Oaks Subdivision. Officer's arriving on the scene discovered a deceased female on the floor of her master bedroom. There is blood spatter on the walls, and lamp in the room. The victim's sister came to the house and discovered the three year old child of the victim walking inside the home. The sister entered the home and discovered the victim. The sister then called the Sheriff's Office.


