1. After filing their motion requesting the court to unseal the search warrants in connection with the investigation into the death of Nancy Cooper that were issued and sealed on July 16, 2008 the movants have become aware of two additional orders sealing search warrants in connection with the investigation – one dated July 21, 2008 (Exhibit C) and another dated July 25, 2008 (Exhibit D).
2. The movants thus far have been unable to determine whether either Exhibit C or Exhibit D was issued in response to a written motion or other supporting document(s), but respectfully submit that both are facially deficient for the reasons set forth in the movants' Memorandum of Law in Support of Motion to Unseal Search Warrants.





ORDER PURSUANT TO NCGS 132.1.4(e)


IN RE: Search Warrant - Office R3-317 in Building #9 at 7100 Kit Creek Road,
Morrisville, N.C. (Wake County)

This cause having come on to be heard by the undersigned Superior Court Judge upon motion by the State and it appearing to the court that:

1. That the information contained in the search warrant, application and possible return results thereof fall within the purview of NCGS 132.1.4 (c).
2. That the release of this information will jeopardize the right of the State to prosecute a defendant or the right of a defendant to a fair trial or will undermine an ongoing or future investigation within the meaning of NCGS 132.1.4 (e).

It is therefore ORDERED, pursuant to NCGS 132.1.4 (e), (k), that this motion, order, search warrant, search warrant application and return results thereof be sealed and held by the Wake County Clerk of Court for an initial period of thirty (30) days from this date, subject to court order prior to this time.
