

PROBABLE CAUSE AFFIDAVIT

CONTINUATION OF THE SEARCH WARRANT APPLICATION IN THE MATTER
OF ANTHONY JOSEPH BIMBO.

On March 28, 2008 a residential breaking and entering incident occurred at 925 E. Wait Ave. Wake Forest. Electronics, jewelry and currency were taken from inside the residence. In August 2008, Durham Police Department provided information pertaining to out of town pawns. While reviewing the pawn information I observed numerous pawn transactions occurring by a subject named Anthony Joseph Bimbo. After discovering the above information I contacted Investigator Alderman with Wake County Sheriff's Department. Information pertaining to Anthony Joseph Bimbo was provided to Investigator Alderman. The information provided to Investigator Alderman lead him (Investigator Alderman) to area pawn shops and property from a Wake County breaking and entering incident was located .Anthony Joseph Bimbo was arrested on 09/05/2008 for breaking/entering and obtaining property by false pretense.

Information obtained from Investigator Alderman revealed that Anthony Joseph Bimbo was possibly a suspect in numerous residential breaking and entering incidents in Wake County, Franklin County and Wake Forest. Additional pawn information was obtained from Durham Police Department and Wake County Sheriff's Department pertaining to Anthony Joseph Bimbo. Further reviewing of the pawn information provided by Durham Police Department revealed that Anthony Joseph Bimbo had pawned numerous items (jewelry) in the month March. These pawn items matched items taken from 925 E. Wait Ave. Wake Forest. Further investigation revealed that the items (jewelry) pawned in March by Anthony Joseph Bimbo had been sold or scraped. My investigation into Anthony Joseph Bimbo continued.

PROBABLE CAUSE AFFIDAVIT


On 09/30/2008 information obtained from Detective Woody with Franklin County revealed that Anthony Joseph Bimbo was a suspect in a residential breaking and entering incident that occurred at 124 Cedar Creek Lane Youngsville N.C. 27596. A witness to the above incident was able to provide a vehicle registration for the suspect vehicle.


Registration revealed that the suspect vehicle was registered to Anthony Joseph Bimbo. The witness was also able to provide a description of the suspect, which matched that of Anthony Joseph Bimbo. Detective Woody was able to obtain an arrest for Anthony Joseph Bimbo.

Further investigation revealed that Anthony Joseph Bimbo worked for McCracken Propane out of Rolesville N.C. 27571. Information obtained from McCracken Propane revealed that on March 28th, 2008 Anthony Joseph Bimbo was at the residence located at 925 E. Wait Ave. Wake Forest. A receipt obtained from McCracken Propane verified that Anthony Joseph Bimbo was at the address.

Information obtained on 10/26/2008 revealed that Anthony Joseph Bimbo had rented a storage unit at 12030 Stickman St. Wake Forest N.C. 27587. It is in my experience that persons who commit property crimes sometimes rent a storage unit to store and conceal the stolen property.
