


Probable Cause Affidavit

I, Detective A.J. Salmon, of the Raleigh Police Department have been a law enforcement officer for approximately twenty two years. I am currently assigned as a Detective to the Major Crimes Task Force of the Raleigh Police Department specializing in the investigation of serious assaults and murder. I have been assigned to Raleigh Police Investigations for approximately fourteen years. I completed Basic Law Enforcement Training at the Raleigh Police Department in 1986. I have received specialized training in all areas of North Carolina criminal law to include abuse, assaults and murder. During my career as law enforcement officer I have been involved in the investigation, arrest and conviction of numerous persons charged with assorted criminal violations including assaults and homicide. I enforce all violations under North Carolina law.

On 4-10-08 at approximately 0500 hrs. the manager of the business located at **1741 Trawick Rd**. was found deceased on the floor of the business. The scene indicates that he died by violent means. The fiancé, Russell Hewitt III, was on the scene upon the Raleigh Police Departments arrival to the scene and was identified as the initial 911 caller. Several vehicles were located in the parking lot of the business. No known suspects have been developed at this time.


