PROBABLE CAUSE: I, T. F. Winner, have been a duly sworn law enforcement officer with the Garner Police Department for five years. Prior to being duly sworn with the Garner Police Department I was a duly sworn Deputy Sheriff with the Athens County Sheriff's Office located in Athens Ohio for seven years. I am currently an Investigator with the Garner Police Department assigned to the investigations division. In my law enforcement career I have investigated and/or assisted in the investigations of various crimes including, homicides, suspicious deaths, breaking and entering and robberies, many of which have resulted in arrests and convictions. I have received training in various areas of investigation including custodial and non-custodial interviewing and interrogation, crime scene processing, and forensic anthropology.

PROBABLE CAUSE CONTINUED:

The applicant swears to the following facts to establish probable cause for the issuance of a phone records production order: On February 17, 2009 the victim, Mayela Orduna sustained fatal injuries on Aversboro Rd., Garner NC, which was the result of an apparent fall from a motor vehicle. Prior to the discovery of the victim, she had attended a party at 3200 Madison Farm Ct. Apt. 102, which is leased by Carl Spencer Bolick. Persons present at the party included, but was not limited to, Carl Spencer Bolick, Jared Huntington, Alisha Lands, Rachael Chicoli and Tara Rich. The events leading up to the incident suggests that the victim, Mayela Orduna, and Carl Spencer Bolick left the party in Mr. Bolick's vehicle because of a physical altercation between Mayela and Tara Rich. Mr. Bolick returned alone and told persons at the party that Mayela had "jumped from the vehicle" and was laying alongside Aversboro Rd. Several persons, in separate vehicles, returned to the location and a subsequent call was made to 911 by Alisha Lands. At the time Mayela allegedly jumped from the vehicle, Bolick was engaged in phone conversation with Tara Rich. All the above mentioned persons, then returned to 3200 Madison Farm Ct apartment 102 and fabricated a story of how the incident occurred, in order to avoid responsibility for the victim's injuries.

Through investigative means it was determined that Carl Spencer Bolick is the account holder of Verizon Wireless number [REDACTED].
 It is hoped that the text message content requested will provide more information or insight into the incident, which lead to death of the victim.
