

Attached is a copy of a letter received by [redacted] Purchasing Department, CITY OF HICKORY, Hickory, N. C. The letter was provided to SA [redacted] FBI, Hickory Resident Agency, on 8/1/95, by Lieutenant [redacted] HICKORY POLICE DEPARTMENT.

A review of the letter reveals that the letter contains several rambling statements critical of Senator HELMS; however, it does not contain any direct threats. The letter contains a return address of "C. RADAR PPT CO, 793 Rt. 56, S., Mount Sterling, O. 43143," and is postmarked in Columbus, Ohio.
