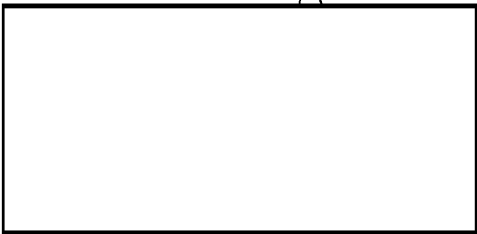

[redacted] was advised of the official identity of the interviewing agent as well as the official identities of two officers from UNITED STATES CAPITOL POLICE who were present during this interview. [redacted] was advised of the purpose of the interview which was to determine his intentions in causing physical harm to Senator JESSIE HELMS and Congressman NEWT GINGRICH whom [redacted] had been reported by his teacher [redacted] as having stated that he wanted to kill those individuals.

[redacted] had no intentions on carrying out his threats and had just made the statement to [redacted] for the sake of making a statement.

[redacted] advised that he resides with [redacted]
[redacted]

When asked if he understood the implications of threatening to cause harm to members of Congress [redacted] advised that he was aware of the fact that such a threat could be presented to the United States Attorney's Office for prosecutive opinion. [redacted] indicated that he was not concerned that he might be prosecuted and advised the interviewing agent that it would be a waste of time to pursue such a charge because he did not intend to act out on his threat.

[redacted] DOB: [redacted] was advised of the official identity of the interviewing agent and the nature of the interview. [redacted] provided the following information.

[redacted] advised that his social security account number is [redacted]

[redacted] "I hate Republicans, I'm going to kill NEWT and JESSIE HELMS". When [redacted] heard [redacted] make the statement he told [redacted] that it was not appropriate to make such comments. [redacted] told [redacted] that Freedom of Speech allowed him to say anything he wanted to say.

[redacted] tried to encourage [redacted] to back down on his comment but [redacted] would not and because of the sincere manner in which [redacted] made the statement, [redacted]

When asked if [redacted] thought [redacted] was capable of carrying out his threat, [redacted] stated that he did. He advised that [redacted]

[redacted] advised that he was so sure that [redacted] might act upon his threat that he reported the incident to the [redacted] and would not have done so otherwise.

[redacted] was asked if he had ever heard [redacted] make any other threats against any other individuals. [redacted] stated that he had not overheard any other statements.

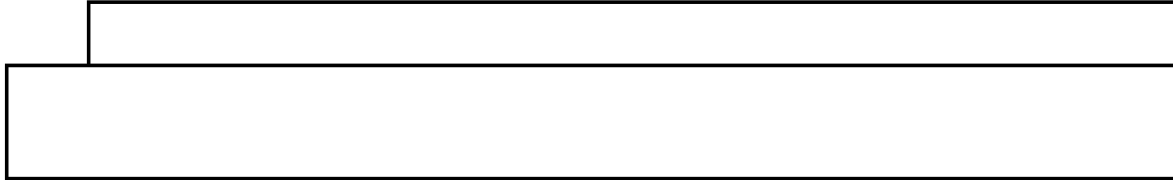
