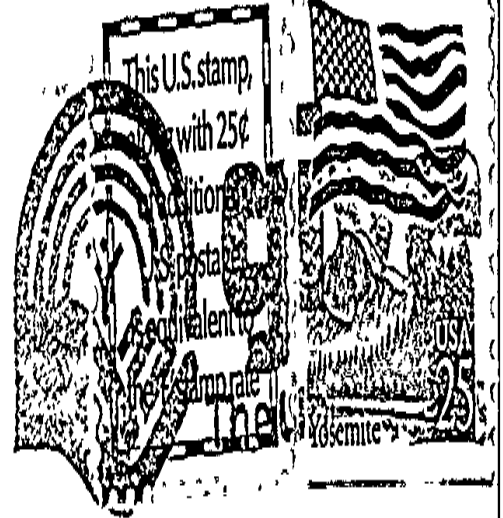

Based upon the guilty plea of the defendant in this case, IT IS HEREBY ORDERED, ADJUDGED, AND DECREED That the defendant be and is hereby convicted of the crime of **Theft in the Fourth Degree**, a serious misdemeanor, in violation of Section(s) 714.1(3) and 714. (4) of the Iowa Criminal Code.

IT IS FURTHER ORDERED That the defendant be and is hereby sentenced to serve a term of one year (365 days) in the Lee County Correctional Center, less credit for time served since August 27, 1991.

IT IS FURTHER ORDERED That the defendant be and is hereby ordered to pay court costs and victim restitution to Kingsley Inn, Fort Madison Iowa, in the amount of \$363.16.

IT IS FURTHER ORDERED That the defendant be and is hereby ordered to pay court-appointed attorney fees in the amount of \$160.00.

IT IS FURTHER ORDERED That the defendant may perform community service work for the Lee County Sheriff at minimum wage rate of \$4.35 per hour in lieu of payment of the court costs and attorney's fees. Written verification of defendant's successful completion thereof shall be filed with this Court.

Bond on appeal is fixed in the amount of \$1,000.00. All other bonds are hereby exonerated.

incarcerated in Lee County, Davenport [redacted]
[redacted] had also read books which
linked Senator Helms and the Central Intelligence Agency (CIA) in
a conspiracy to kill John F. Kennedy. Therefore, as [redacted] is
a fan of President Kennedy, he proceeded to write the enclosed
letter.

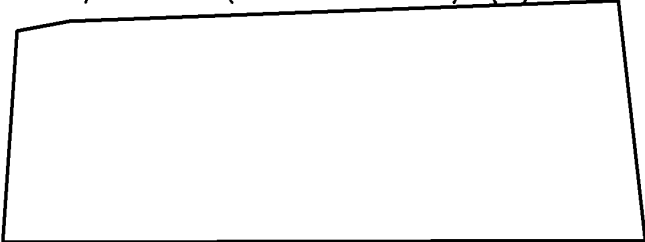
