UNSUB, AKA [redacted] SENATOR JESSE HELMS-VICTIM; CAS; OO:DETROIT

[redacted] EXECUTIVE ASSISTANT TO SENATOR HELMS,

WASHINGTON, D.C., PROVIDED WFO WITH TWENTY-FOUR (24) POSTCARDS WHICH WERE RECEIVED AT SENATOR HELMS RESIDENCE IN RALEIGH, NORTH CAROLINA IN SEPTEMBER AND OCTOBER, 1984. THE CARDS APPEAR TO BE WRITTEN BY THE SAME PERSON AND ARE POSTMARKED WINDSOR, ONTARIO; GREENSBORO, N.C.; DETROIT, MICHIGAN; ROYAL OAK, MICHIGAN; AND U.S. POSTAL SERVICE, MICHIGAN.

THE GENERAL TONE OF THE TEXT IS THAT SENATOR HELMS IS THE MOST POWERFUL MAN IN THE U.S. AND CONTROLS THE COUNTRY BY HYPOCRISY.

THE UNSUB OCCASIONALLY SIGNS THE CARDS [redacted] WITH A SIGNATURE AND

BLAMES SENATOR HELMS FOR THE DEATH OF HIS MOTHER, PRINCESS GRACE OF MONACO, JOE LOUIS, HAYWARD BROWN, AND MILLIONS OF OTHERS "WITH HYFNOTISM IN SUPPORT OF NAZI [REDACTED] AT SMIRKE DONUT".

IN ONE TRAVELING ACCOUNT UNSUB STATES "WAS GOING TO DROP BOMB". IN ANOTHER HE CLAIMS "THE MOST SERIOUS, HATEFUL, COWARDLY CRIME YOU NAZIS COMMITTING SENT SECRET SERVICE TO ASSASSINATE ME".

UNSUB THINKS SENATOR HELMS KILLED HIS MOW HOPIING HE WOULD COMMIT SUICIDE.

SENATOR HELMS HAS EXPRESSED SOME CONCERN SINCE UNSUB HAS HIS HOME ADDRESS. IT IS NOTED ONE OF THE POSTCARDS BEARS A GREENSBORO, N.C. POSTMARK.

ORIGINAL CARDS WILL BE SUBMITTED TO FBI LABORTARY UNDER SEPARATE COVER FOR ANALYSIS.

COPIES OF CARDS WILL BE PROVIDED CHARLOTTE AND DETROIT TO ASSIST IN IDENTIFYING UNSUB.

WFO INDICES CONTAIN NO REFERENCE IDENTIFIABLE WITH UNSUB.

On 11/5/84, SA [redacted] NORTH CAROLINA STATE BUREAU OF INVESTIGATION (NCSBI), Raleigh, North Carolina, was contacted and advised that his department maintains an indices for anonymous type threats and a review of his indices regarding the unknown subject known as [redacted] was reviewed with negative results. [redacted] noted his office would be alert to any possible threats concerning Senator JESSE HELMS and if pertinent, would immediately advise the FBI Office in Raleigh, North Carolina.

On the same date, Major [redacted] Raleigh, North Carolina, Police Department was contacted and advised of the contents of referenced communication and stated his office could provide no pertinent information regarding the unknown subject. He related he had been in contact with Senator HELMS in reference to another threatening matter and had provided Senator HELMS with a Varter Alarm System which would allow Senator HELMS to have immediate contact with the police department should he encounter any difficulties. Major [redacted] noted that Senator HELMS resides in Raleigh, North Carolina, and the police department routinely checks his house on a regular basis. Major [redacted] stated should he develop any pertinent information regarding this matter, he would immediately contact the FBI Office in Raleigh, North Carolina.

On 1/8/85, Major [redacted] Supra, was recontacted and noted that Senator HELMS had returned to Washington, D. C., and during the period of time from the election until the New Year, his department routinely checked in with the Senator who did not encounter any difficulties or receive any additional threatening communications.

In view of the fact that all logical investigation has been completed by the Charlotte Division, this matter is considered RUC'd.
