

Affiant has over fifteen hundred hours of formal training; Affiant has also been a part of numerous undercover purchases on the state and federal level. This Affiant has made numerous undercover drug buys. Through formal training (Police Law Institute, Narcotics Investigation) multiple homicide training courses and on-the-job experience, Affiant has applied for, received, and executed numerous search warrants for controlled substances and assisted in the execution of search warrants of illicit narcotics violations. I make this affidavit based on my personal knowledge together with information received and corroborated from confidential sources that, through my observation, I believe to be credible.

01-09-2010, Mr Kenneth Ring was working as the manager of Domino's Pizza in Knightdale. At approximately 0030hrs Mr Ring was assaulted with some type of blunt object and robbed. Mr Ring was transported to Wake Medical Center, where on 01-11-2010 about 1730hrs Mr Ring succumbed to his injuries and died. This search warrant is requested to try to identify suspects, motive or any other involvement by this victim.

This cellular phone was located in the crime scene of Domino's Pizza 2001 Wide Waters Pkwy "R" Knightdale NC 27545 near Mr. Ring and the location of where the assault occurred. This cellular phone was later identified as belonging to Kenneth Ring, *Phone account identified by Sprint as Kenneth Ring's*

I contend that Probable Cause exists to search Boost Mobile Cellular phone, model number I465 with a telephone number of \_\_\_\_\_, for the listed items based on the fact of so many unanswered questions, and I believe there is evidence, in or on this ~~residence~~ *CELLULAR PHONE* listed above.
