Disadvantages of Mistrial

- 1) waste of a week
- 2) could affect Hall's attitude & other witnesses
- 3) possibly waste of 2 weeks unless Allen can set up quick docket
- 4) inconvenience to all concerned

Advantages of Mistrial

- v1) different judge
- v2) better prepared to select jury & handle motions / more organized
- v3) avoid longer jury selection & having jury in Toulon because of their concerns about retaliation.
- v4) fresh start w/ new jury from another county.
- v5) avoid reversible error if new trial on behalf of Dyl - witness interviews
- v6) can enlist Don Johnson's help
- v7) opportunity to separate Shepard from others to keep out Hall's letters.
- v8) time to have case well prepared & organized.
