

Local Sales Tax Revenue Distribution Estimates: Comparison of Current Law and Conference Committee Report for HB97

Current Law estimates include all Local Option Sales Tax Articles currently levied and assume the following economic growth rates: per the Consensus Revenue Forecast, 5.4% in FY 2015-16 and 4.6% in FY 2016-17; 3.5% in future years. Per capita estimates incorporate county-level population projections from the Office of State Budget and Management.

Conference Report estimate for FY 2015-16 includes \$18.7 m in revenue from Base Expansion, distributed per current law.

Conference Report Changes for FY 2016-17 and beyond include: (1) Revenue distributed under Conference Report Section 32.19.(e), including required redistributions in FY 2017-18 and beyond, and (2) Revenue realized under Articles 43 and 46 due to the sales base expansion.

All estimates are rounded to the nearest \$1,000; therefore, totals may not match dollar amounts specified in Conference Report Section 32.19.
