	REPORTING OFFICER WAS ASSISTING A DISABLED MOTORIST AT THE INTERSECTION OF WATER HILLS LN AND UNION CHURCH RD. BURGESS TOWING HAD BEEN CONTACTED BY THE MOTORIST BEFORE I CHECKED OUT WITH HIM. I WAITED FOR THE WRECKER TO ARRIVE. WHEN THE WRECKER ARRIVED ON SCENE I STOPPED TRAFFIC SO THE WRECKER COULD GET IN POSITION TO LOAD THE VEHICLE UP. THE FIRST CAR I STOPPED WAS A SILVER CROWN VIC. AS THE VEHICLE APPROACHED ME THE DRIVER HAD HIS LICENSE OUT THE WINDOW IN HIS HAND. AS I REACHED FOR THE LICENSE AND STARTED TO TELL HIM TO WAIT FOR THE WRECKER I SMELLED A STRONG ODOR OF MARIJUANA COMING FROM THE VEHICLE. I TOLD THE DRIVER (EULANDO UTLEY) TO PULL OVER ON THE SHOULDER OF THE ROAD. I HAD HIS LICENSE IN MY HAND WHILE HE APPEARED TO START TO PULL OVER. AS HE WAS PULLING OFF I NOTICED WHAT APPEARED TO BE A BRICK SHAPED OBJECT IN THE PASSENGER SEAT THAT APPEARED TO BE MARIJUANA WRAPPED IN PLASTIC. ALL OF A SUDDEN THE VEHICLE TOOK OFF AT A HIGH RATE OF SPEED HEADING TOWARDS VASS N.C. I RAN TO MY CAR AND PROCEEDED TO CATCH UP WITH HIM. BY THE TIME I COULD CALL IN TO DISPATCH I WAS GOING PAST MAMA'S KITCHEN ENTERING VASS CITY LIMITS. AS I WENT OVER THE HILL I SAW THE VEHICLE IN A DISTANCE OF ABOUT THREE TENTHS OF A MILE HIT HIS BRAKES AND THEN START AROUND ANOTHER VEHICLE IN THE CURVE. AS THE TWO VEHICLES ROUNDED THE CURVE I LOST SIGHT OF THE VEHICLE AND PROCEEDED TOWARDS VASS. I PAST ONE OF THE VEHICLES (A SMALL BLUE CAR) ON THE SIDE OF THE ROAD JUST AROUND THE CURVE. I WENT PAST LINCOLN AVE ON INTO VASS AND COULD NOT FIND THE VEHICLE. I WAS IN CONTACT WITH DEPUTY SHAMBURGER WHO WAS IN THE AREA. I HAD ASKED HIM HIS LOCATION TRYING TO FIGURE OUT WHERE THE VEHICLE WENT AND 911 WAS GIVING OUT A WRECK AT 210 UNION CHURCH RD STATING THAT A CAR HAD HIT A HOUSE. MY SELF AND DEPUTY SHAMBURGER LOCATED THE VEHICLE UNDER THE HOUSE AT THE INTERSECTION OF LINCOLN AVE AND
