Description of Items to be Seized

1. Evidence of ownership or possession of Vehicle a 1993 Ford Escort with North Carolina license plate XZR 2028.
2. Blood, semen, saliva, physiological fluids and secretions, hair, fibers, fingerprints, palm prints, footprints, shoeprints, weapons, and firearms, including, pistols, revolvers, rifles, shotguns, hatchets, axes, cutting instruments, and cutting tools, blunt force instruments, bullets, cartridges, fired cartridges, and items containing traces of any of the above mentioned articles.
3. Clothing, physical layout of the vehicle, moving pictures, video, still pictures to preserve the nature of the crime scene, and any and all evidence that may relate to the crimes in question.

The vehicle is currently parked 4640 Grinding Stone Dr. Raleigh, NC and is being secured by Raleigh Police Detectives.

Probable Cause Affidavit

I, Detective Z.A. Morse have been a Law Enforcement Officer with the Raleigh Police Department for 13 years and 6 months. I am currently assigned to the Major Crimes Task Force of our investigative division. I have received training in crimes through the North Carolina Justice Academy, Raleigh Police Department's Academy, and regularly scheduled in-service training sessions dealing with laws of arrest, search and seizure, interviewing, the preparation of a search warrant and criminal investigation. I have conducted investigations that have led to the arrest and conviction of individuals for violations of North Carolina general statues. I have obtained and executed numerous search warrants in the past that have led to the arrest and conviction of suspects.

On April 4th 2009 Raleigh Police officers responded to a reported vehicle accident in the 7300 block of Parrot Drive in Raleigh, NC. Upon their arrival, they discovered that the person in the vehicle, identified as Calvin Dae, was deceased and that he had injuries consistent with homicidal violence. A homicide investigation ensued and it was determined upon speaking with Jeremy Nelson who is an associate of Calvin Dae; Jeremy Nelson and Calvin Dae were together a short time before his death. Calvin Dae tried to make some phone calls from his personal cell phone but was unsuccessful because the phone battery died. Calvin Dae used Jeremy Nelson's cell phone. One of these phone calls placed by Calvin Dae was to Chandler Avery.

Upon searching the victim's vehicle for forensic evidence, fingerprints belonging to Chandler Avery were found in the victim's car. A short distance from the victim's car was bags of clothing. One of these bags contained clothing that was covered with a substance that resembled blood.

It was later learned that Chandler Avery had arrived at a home in south Raleigh early in the morning, a few hours after the murder. When Detectives arrived at this home the Detectives located a twenty dollar bill lying in the street directly in front of the home where Chandler Avery was supposed to be located. This twenty dollar bill also had a substance on it that resembled blood. Upon interviewing the residents of this home it was learned that Chandler Avery did in fact arrive at the home in the early morning hours and had spent a few hours there before leaving, just prior to the Detectives arrival.

During the course of the investigation thus far and attempts to locate Chandler Avery numerous associates of Chandler Avery's were spoken to. These interviews have resulted in the following information being ascertained. Chandler Avery is considered homeless. The fact that bags of clothing were found near the scene lends credence that the suspect was attempting to remove clothing that could constitute homelessness. Chandler Avery has been sleeping in the above mentioned vehicle which is parked at 4640 Grinding Stone Dr. This is an address within an apartment complex and the vehicle is in the parking lot. This vehicle is reportedly disabled and not able to be driven.

This vehicle is registered to Talonda Goodson. Detective Thompson spoke with Ms. Goodson and ascertained that she is a cousin of Chandler Avery's and he had possession of her vehicle.

This search warrant is needed to seize, transport to another location so that the vehicle can be examined, and processed by Detectives and CCBI for latent fingerprints, photographs, video tape, Blood, semen, saliva, physiological fluids and secretions, hair, fibers, fingerprints, palm prints, footprints, shoeprints, weapons, and firearms, including, pistols, revolvers, rifles, shotguns, hatchets, axes, cutting instruments, and cutting tools, blunt force instruments, bullets, cartridges, fired cartridges, and items containing traces of any of the above mentioned articles. Including but not limited to personal property, clothing, or any other articles that could be related to the victim, possible suspects, and the crime of Murder, or any other crimes.
