The residence and curtilage located at 1808 Lucas Road Knightdale, North Carolina 27545. The residence is a one-story home. The residence has light in color vinyl siding with dark colored shutters. The residence has a brick foundation, and a porch that stretches the length of the home. The porch rails are white in color. The front door is also white in color, with the top half being that of pane windows. There is a gravel driveway, and positioned at the end is a mailbox duly erected with the numbers 1808 clearly visible.

On the premises there are two vehicles. A silver in color, 2004 4-door Pontiac Grand AM, bearing North Carolina registration TRL-1243 VIN, is parked in front of the residence. Parked off to the right side of house is a second vehicle. The second vehicle is a black in color, 2008 Pontiac G6, bearing North Carolina registration XYC-8155 VIN

The structure and vehicles to be searched is located by the following directions: From downtown Raleigh, NC take S McDowell Stree/US-401 N/US-70 W/NC-50 N, continue to follow US-401 N, Merge onto I-540 E toward US-64/US-264/Rocky Mount/Wilson, take the Buffaloe Road exit, Exit 20, turn left onto Buffaloe Road, turn right onto Lucas Road, follow to 1808.

Continuation of: Probable Cause;

This affiant swears to the following facts establishing probable cause for the issuance of a Search Warrant. Affiant has been a sworn Law Enforcement Officer for over eleven years and is currently an Investigator for the Wake County Sheriff's Office Person Crimes Unit. Affiant has an Associate's Degree from Wake Tech Community College, 124 credit hours from North Carolina Wesleyan College, and possesses an Advanced Law Enforcement Certification from the State of North Carolina's Sheriff's Education and Training Standards Commission. Through formal training and on-the-job experience, affiant has investigated and participated in the investigations of adults and juveniles, both suspects and victims of crimes. I have received, and continue to receive, specialized training through schools, and seminars related to a variety of crimes. I have completed

training in the interview and interrogation of suspects, witnesses and informants. I am also, a certified instructor and Specialized Driving Instructor; and I assist with the training of new deputies and teach many blocks of instruction. Affiant has applied for, received, and executed numerous search warrants and assisted in the execution of search warrants. This affiant makes this affidavit based on my personal knowledge together with information received from other persons this affiant believes to be credible.

On June 4, 2009 at 0340 hours the Wake County Sheriff's Office received information that a subject had been shot at 1808 Lucas Road Knightdale, North Carolina. Officer's arriving on the scene discovered a deceased male outside the residence with what appears to be a gunshot wound in the area of his mouth. A casing of unknown make and model was found near the deceased. The decedent was found lying on his stomach. The decedent's wife and daughter were in the home asleep and reported hearing what they believed to be a scream and then a gunshot. Upon discovering her husband, she called 911.

The crime scene located at 1808 Lucas Road, Knightdale, North Carolina needs to be searched and processed for evidence and instrumentalities of this death. The items searched for will be blood evidence, trace evidence, writings of identification, instruments and items used to cause the death of the victim, evidence and items that will hopefully identify the person or persons responsible for the death of the victim.

The affiant respectfully requests the court issue a Search Warrant to search the premises, and the vehicles parked therein and the curtilage of 1808 Lucas Road Knightdale, North Carolina.
