4. Shall live in a residence approved by the probation officer.
5. Seek and maintain gainful employment, or be in an educational or vocational training program approved by the probation officer.
6. Report any criminal arrest to the probation officer within twenty-four hours.
7. Not use intoxicants to excess, nor use or possess any illegal drugs.
8. Shall serve the first six months in the Manistee County jail, with credit for 140 days.
9. Pay a fine of \$100.00, court costs of \$100.00, and restitution of \$200.00.
