Facts to Establish Probable Cause

Detective Michele Soucie, hereinafter designated as affiant, having been duly sworn according to law, deposes and says that: affiant is a Durham Police Detective, who is currently assigned to the Durham Police Department's Criminal Investigation Division. The affiant has been a sworn law enforcement officer with the State of North Carolina since 1999. The affiant has participated in and/or conducted numerous investigations involving crimes of violence to include but not limited to; aggravated assaults involving firearms, robberies, sexual assaults, homicides, and the physical and/or sexual abuse of children. Additionally, the affiant has attended numerous schools and received training throughout her tenure as a law enforcement officer including.

1. On February 24, 2011, the Durham Police Department executed a search warrant at 2109 Pear Tree Lane, Durham, NC pursuant to a missing person/homicide investigation. One of the persons of interest in this investigation is Pete Lucas Moses Jr., who was at this location.
2. During the course of this investigation it was discovered that Pete Lucas Moses Jr. has posted videos on the internet which may contain information relevant to this investigation. It was verified by Investigator C. A. Robinson that Pete Lucas Moses Jr. had a YouTube account with the YouTube ID of: sisqo2k7.

Based on this Investigator's training and experience, evidence to include those items listed on the sheet entitled *Description of Items to be Searched & Seized* may be located within the described premises. Based on the information set out in this affidavit, there is probable cause to believe that the items seized may be of evidentiary value to this investigation. Detective Soucie respectfully requests that a search warrant be issued for the records held in the custody and control of Google Inc.




