

GASOLINE TAXES

January 2011

Nationwide

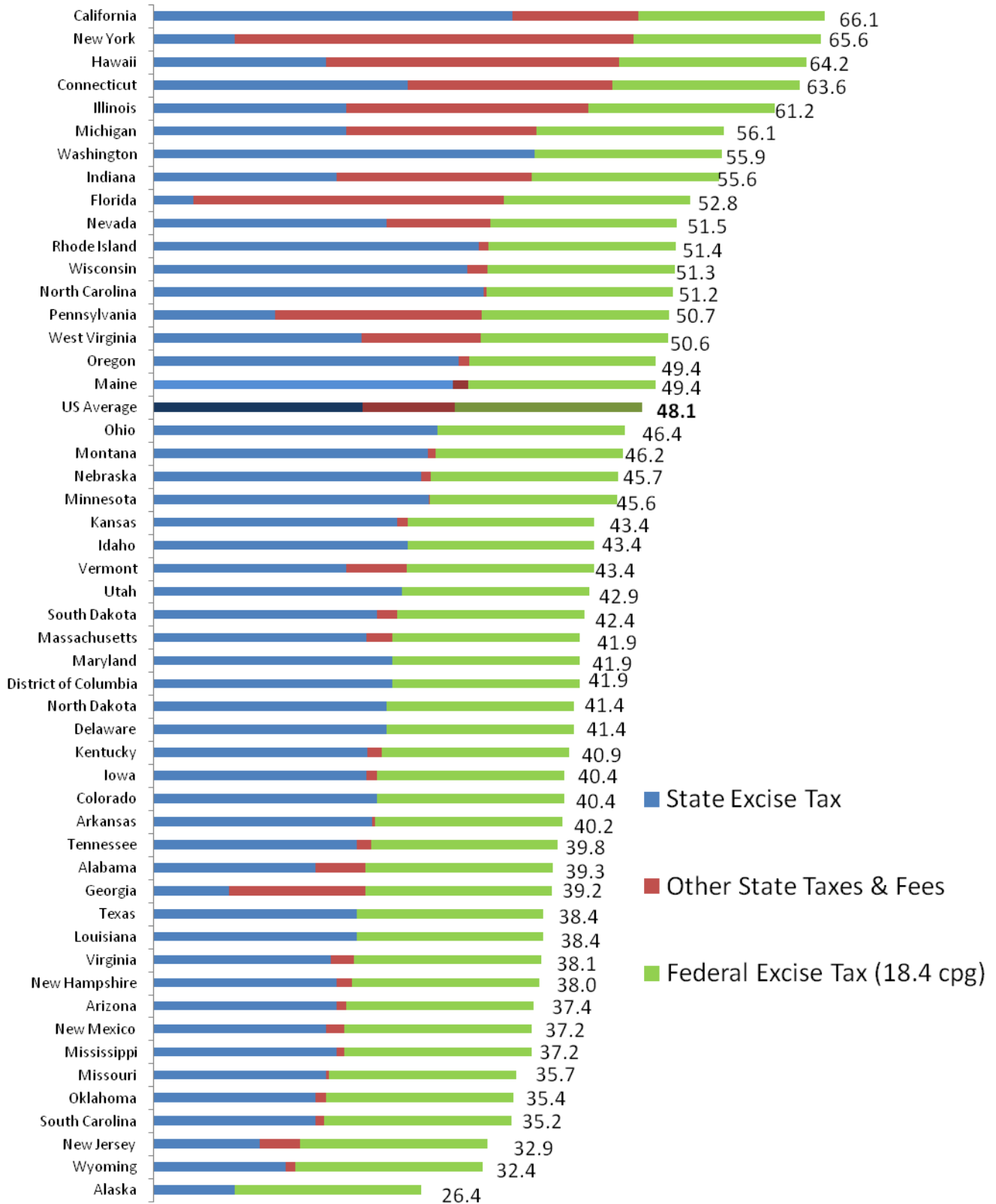
The nationwide average tax on gasoline of 48.1 rose 0.7 cents since October 2010. A summary of federal and state excise taxes and other taxes collected on gasoline is shown below. The federal tax on gasoline is 18.4 cents per gallon. The average state gasoline excise tax is 20.6, up from 20.5 cents the previous quarter. Other taxes (such as applicable sales taxes, gross receipts taxes, oil inspection fees, county and local taxes, underground storage tank fees and other miscellaneous environmental fees) are up to 9.0 cents per gallon from 8.5 cents per gallon from October. Adding these taxes and fees to the state excise taxes results in a volume-weighted average state and local tax of 29.7 cents per gallon.

DIESEL TAXES

January 2011

Nationwide

The nationwide average tax on motor diesel fuel of 53.1 cents per gallon rose 0.6 cents since the October 2010 study. A summary of federal and state excise taxes and other taxes collected on diesel is shown below. The federal tax on diesel is 24.4 cents per gallon. The average state diesel fuel excise tax was 19.2 cents per gallon. Other state and local taxes average around 9.5 cents per gallon. These other taxes include applicable sales taxes, gross receipts taxes, oil inspection fees, county and local taxes, underground storage tank fees and other miscellaneous environmental fees. Adding these taxes and fees to the state excise taxes results in an average state and local tax of 28.6 cents per gallon.
